Subject: Request for allotment of land in respect of newly established office of the Manipur Staff Selection Commission – Regarding.

Sir,

In inviting reference to the above, I am to state that the newly established Commission has no office building as on date, even though the Commission has started functioning w.e.f. the 2nd September, 2024 at the Extension Training Centre Office Building of RD & PR Department located within the office complex of DC Office, Imphal West, Lamphelpat with the few skeleton officers/officials assigned to the Commission in addition to their normal duties, who are also looking after many other Departments. The 3(three) Personal Casual Peons as entitled to the Chairperson are also attending/assisting in discharge of the duties of the Chairperson.

2. This new Commission is likely to face lots of administrative inconveniences while discharging its assigned duties and functions, as the Commission has neither any office building nor any land allotted to the Commission. As the Commission Office is located within the office complex of DC Office, Imphal West, Lamphelpat; there is every possibility of having lots of difficulties and inconvenience, whenever any kind of Election is conducted by the DC/DEO, Imphal West in the near future.

3. Further, I am to state that the Commission shall require its own Office Building, Strong Rooms, Examination Hall, Residential Quarters of the Chairperson and other Members, if they happen to be outsiders. Hence, there is an essential need to have independent land for the Commission itself. At least, a minimum of 1.00 acre land is required for the Commission for construction of the above stated infrastructures.

4. In view of the above justified reasons and to enable the Commission to run its offices smoothly and independently, the State Government is requested



to kindly allocate land measuring an area of at least 1.00 acre, preferably within a radius of 6 or 7 kilometers from Imphal (Zero Km point) either in Imphal West or Imphal East District in favour of the Commission. Most preferable site proposed is near the Civil Secretariat Complex, Mantripukhri.

5. This is issued with the approval of the Competent Authority.
