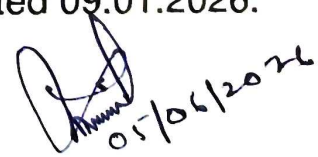
2. In the event of the candidates having the same scores after normalization, such cases have been resolved by applying the following criteria:
